If you request it, your request for hard copies of the provider directory remains until you leave Imperial Health Plan or request that hard copies be discontinued.

Section 1 – Introduction

This directory provides a list of Imperial Health Plan’s network providers.

You will have to choose one of our network providers listed in this directory to be your **Primary Care Provider (PCP)**. Generally, you must get your health care services from your PCP.

What is a PCP?

Your PCP is a physician who meets state requirements and is trained to give you basic medical care. You will get your routine or basic care from your PCP. Your PCP can also coordinate the rest of the covered services you need. In most cases, you must see your PCP to get a referral before you see any other health care provider.

“Coordinating” your services includes checking or consulting with other plan providers about your care and your progress. If you need certain types of covered services or supplies, you must get approval in advance from your PCP (such as giving you a referral to see a specialist). In some cases, your PCP will need to get prior authorization (prior approval) from us.

The network providers listed in this directory have agreed to provide you with your health care services. You may go to any of our network providers listed in this directory; however, some services may require a referral. If you have been going to one network provider, you are not required to continue going to that same provider. In some cases, you may get covered services from non-network providers.

What if you use out-of-network providers to get covered services?

Out-of-network providers are providers that are not part of Imperial Health Plan. You must use network providers except in emergency or urgent care situations. If you obtain routine care from out-of-network providers neither Medicare nor our plan will be responsible for the costs. Care or services you get from non-plan providers will not be covered, except for emergency care (including ambulance services and post-stabilization care), urgently needed care, renal dialysis (kidney), and any services covered through an appeals process.

What if you receive a bill from an out-of-network provider?

If an out-of-network provider sends you a bill for covered services that you think should be paid by our plan, please contact Member Services Department at 1-800-838-8271, (TTY: 711) October 1 – March 31: Monday – Sunday, from 8:00 a.m. – 8:00 p.m. or April 1 – September 30: Monday – Friday, from 8:00 a.m. – 8:00 p.m. or Saturday – Sunday, from 10:00 a.m. – 2:00 p.m. We will ask you to send the bill to us so that we can process and determine the amount you owe, if any. If you have already paid for any medical care that we cover, we will reimburse you for our share of the cost.

How to get covered services when you have an emergency?

When you have a “medical emergency,” you believe that your health is in serious danger. A medical emergency can include severe pain, a bad injury, a sudden illness, or a medical condition that is quickly getting much worse.

If you have a medical emergency:

Get help as quickly as possible. Call 911 for help or go to the nearest emergency room, hospital, or urgent care center. Call for an ambulance if you need it. You do not need to get approval or a referral first from your PCP.

As soon as possible, make sure that our plan has been told about your emergency. We need to follow up on your emergency care. You or someone else should call to tell us about your emergency care, usually within 48 hours. Please refer to the information provided on the back of your membership card for specific directions and appropriate phone numbers to call.

After the emergency is over you are entitled to follow-up care to be sure your condition continues to be stable. Your follow-up care will be covered by our plan. If your emergency care is provided by out-of-network providers, we will try to arrange for network providers to take over your care as soon as your medical condition and the circumstances allow.

How to get urgently needed care?

“Urgently needed care” is a non-emergency situation when:

- You need medical care right away because of an illness, injury, or condition that you did not expect or anticipate, but your health is not in serious danger.
- Because of the situation, it isn't reasonable for you to obtain medical care from a network provider.

Whenever possible, you must use our network providers when you are in the plan's service area and you have an urgent need for care. In most situations, if you are in the plan's service area, we will cover urgently needed care only if you get this care from a network provider. If the circumstances are unusual or extraordinary, and network providers are temporarily unavailable or inaccessible, our plan will cover urgently needed care that you get from a non-network provider.

Suppose that you are temporarily outside our plan's service area, but still in the United States. If you have an urgent need for care, you probably will not be able to find or get to one of the providers in our plan's network. In this situation (when you are outside the service area and cannot get care from a network provider), our plan will cover urgently needed care that you get from any provider.

What is the service area for Imperial Health Plan?

The Northern California counties in our service area are listed below: Del Norte, Humboldt, Mendocino, Modoc, Plumas, Shasta, Siskiyou, and Tehama.

Our plan's network also includes providers in other counties in California. To find out about providers in other areas, please call our Member Services Department at 1-800-838-8271, (TTY: 711) or visit our website www.imperialhealthplan.com.

How do you find Imperial Health Plan providers that serve your area?

The PCPs in this directory are organized alphabetically by the cities where they reside, and further listed in alphabetical order by last name within each city. By looking up the city in which you reside, you will be able to find the physicians listed in your area.

The specialty care providers (specialists) are organized alphabetically by the specialty groups they belong to. If there is a particular plan specialist that you want to use, check first to be sure your PCP makes referrals to that specialist. Your PCP choice may restrict you to a specific group of specialists.

Sección 1 – Introducción

Este Directorio ofrece una lista de los proveedores de la red de Imperial Health Plan. Tendrá que elegir a uno de nuestros proveedores de la red que figuran en la lista de este Directorio como su proveedor de atención primaria (**Primary Care Provider** en inglés, o PCP). Por lo general, debe obtener los servicios de atención médica de su PCP.

¿Qué es un PCP?

Su PCP es un médico que cumple con los requisitos estatales y está capacitado para darle atención médica básica. Recibirá su atención médica básica y rutinaria de su PCP. Su PCP también puede coordinar el resto de los servicios cubiertos que usted necesite. En la mayoría de los casos, debe consultar con su PCP para obtener una remisión antes de atenderse con cualquier otro proveedor de atención médica.

“Coordinar” sus servicios incluye verificar o consultar con otros proveedores del plan acerca de su atención médica y su progreso. Si usted necesita tipos de servicios o suministros cubiertos determinados, debe obtener una aprobación anticipada de su PCP (por ejemplo, cuando le da una remisión para consultar con su especialista). En algunos casos, su PCP deberá obtener autorización previa (aprobación de antemano) de nosotros.

Los “proveedores de la red” que figuran en este directorio han acordado brindarle servicios de atención médica. Puede ir a cualquiera de los proveedores de la red que aparezca en el listado de este directorio; sin embargo, para algunos servicios es posible que necesite de una remisión. Si ha estado atendándose a un proveedor de la red, no es necesario que continúe atendéndose con el mismo proveedor. En algunos casos, puede obtener servicios cubiertos de proveedores no de la red.

¿Y si utiliza proveedores fuera de la red para obtener servicios cubiertos?

Los proveedores fuera de la red son proveedores que no forman parte de Imperial Health Plan. Debe usar proveedores de la red excepto en situaciones de atención de

emergencia o urgencia. Si obtiene atención rutinaria de proveedores fuera de la red ni Medicare ni nuestro plan serán responsables por los costos. La atención médica o los servicios que reciba de proveedores no del plan no estarán cubiertos, excepto la atención de emergencia (incluidos los servicios de ambulancia y la atención médica posterior a la estabilización), atención de urgencia, diálisis renal (riñón) y cualquier servicio cubierto por un proceso de apelación.

¿Y si recibe una factura de un proveedor fuera de la red?

Si un proveedor fuera de la red le envía una factura por servicios cubiertos que en su opinión deberían estar cubiertos por nuestro plan, llame al Departamento de Membresía al 1-800-838-8271, (TTY: 711). Del 1 de octubre al 31 de marzo: lunes a domingo, de 8:00 a.m. a 8:00 p.m. o sábado y domingo, de 10:00 a.m. a 2:00 p.m. Del 1 de abril al 30 de septiembre: lunes a viernes, de 8:00 a.m. a 8:00 p.m. Le pediremos que nos envíe la factura para que podamos procesarla y determinar el monto que le corresponde pagar a usted, si hay alguno. Si ya pagó alguna atención médica que cubrimos, le reembolsaremos nuestra parte del costo.

¿Cómo obtener servicios cubiertos cuando tiene una emergencia?

Una “emergencia médica” es cuando usted cree que su salud está en peligro grave. Una emergencia médica puede incluir dolor intenso, una lesión grave, una enfermedad repentina o una afección que se agrava rápidamente.

Si tiene una emergencia médica:

Busque ayuda lo más rápido posible. Llame al 911 para pedir ayuda o acuda a la sala de emergencias, hospital o centro de atención urgente. Pida una ambulancia por teléfono si la necesita. No es necesario que primero obtenga autorización o una remisión del PCP.

Tan pronto como sea posible, asegúrese de avisar al plan acerca de la emergencia. Necesitamos darle seguimiento a la atención de emergencia que reciba. Usted u otra persona deberá llamarnos para informarnos sobre su atención de emergencia, generalmente en un

plazo de 48 horas. Consulte la información proporcionada al reverso de su tarjeta de membresía para instrucciones específicas y números telefónicos que llamar.

Una vez que finaliza la emergencia, usted tiene derecho a recibir atención de seguimiento para garantizar que siga estando estable. Nuestro plan cubrirá la atención de seguimiento. Si recibe atención de emergencia por parte de proveedores fuera de la red, trataremos de que los proveedores de la red se hagan cargo de su atención tan pronto como su afección médica y las circunstancias lo permitan.

¿Cómo obtener atención de urgencia?

La “atención de urgencia” se refiere a una situación que no es de emergencia cuando:

- Usted necesita atención médica de inmediato debido a una enfermedad, lesión o afección imprevista, pero su salud no está en grave peligro.
- Debido a la situación, no es razonable que usted obtenga atención médica de un proveedor de la red.

Siempre que sea posible, usted debe acudir a los proveedores de nuestra red si está en el área de servicio del plan y tiene una necesidad urgente de atención médica. En la mayoría de las situaciones, si está en el área de servicio del plan, cubriremos la atención de urgencia solo si obtiene esta atención de parte de un proveedor de la red. Bajo circunstancias anormales o extraordinarias, cuando los proveedores de la red se encuentran temporalmente indisponibles o inaccesibles, nuestro plan cubrirá la atención de urgencia que obtiene de un proveedor no de la red.

Supongamos que usted está temporalmente fuera del área de servicio del plan, pero está todavía en Estados Unidos. Si tiene una necesidad urgente de atención médica, lo más probable es que no podrá encontrar ni llegar al consultorio de uno de los proveedores en nuestra red. En esta situación (en la que usted está fuera del área de servicio y no puede

obtener atención de un proveedor de la red), nuestro plan cubrirá la atención de urgencia que obtiene a través de cualquier proveedor.

¿Cuál es el área de servicio de Imperial Health Plan?

Los condados de Northern California en nuestro área de servicio se enumeran a continuación. Del Norte, Humboldt, Mendocino, Modoc, Plumas, Shasta, Siskiyou, y Tehama.

La red de nuestro plan también incluye proveedores en otros condados de California. Para obtener información sobre proveedores en otras áreas, llame a nuestro Departamento de Membresía al 1-800-838-8271, (TTY: 711) o visite nuestro sitio web www.imperialhealthplan.com.

¿Cómo encontrar a los proveedores de Imperial Health Plan que atienden en su área?

Los PCP en este directorio están organizados alfabéticamente por las ciudades en las que residen, y luego dentro de cada ciudad aparecen en orden alfabético según su apellido. Al buscar la ciudad en la que usted reside, podrá encontrar los médicos de su área.

Los proveedores de atención especializada (especialistas) están organizadas alfabéticamente por los grupos de especialidad a los cuales pertenecen. Si hay un especialista del plan en particular que usted desee consultar, verifique primero que sus PCP hace remisiones a este especialista. Su elección de PCP podría restringirle a un grupo específico de especialistas.
